





# AUSTRALIA – VIETNAM INVESTMENT **FORUM 2023**

Strengthening Australia and Vietnam bilateral strategic supply chains continues to be a priority for many years and with the support of governments, Australian and Vietnamese business have invested in one another's economies in a broad range of industries including resources, agriculture, manufacturing, education, and services.

In 2022, two-way trade between Vietnam and Australia enjoyed record year-onyear growth of around 27% to US\$15.7 billion<sup>1</sup>. As of February 2023, Australia's cumulative investment in Vietnam reached US\$1.99 billion, ranking 20th among foreign investors in Vietnam<sup>2</sup>. Vietnam's cumulative investment in Australia hit US\$592.4 million.

Bolstering two-way trade and investment is a joint priority and in 2023 – our 50<sup>th</sup> anniversary year of bilateral diplomatic relations - to build on these experiences and develop a stronger culture of investment between our economies, Australian Trade and Investment Commission (Austrade) in partnership with counterpart agencies will deliver a series of Australia - Vietnam Investment Forums. This is the first Forum to take place in Hanoi.
