DECREE FOR

AMENDMENT AND SUPPLEMENT OF SEVERAL ARCICLES
OF DECREE NO. 152/2020/ND-CP DATED DECEMBER 30TH, 2020 OF
THE GOVERNMENT REGARDING FOREIGN WORKERS
WORKING IN VIET NAM AND RECRUITMENT, MANAGEMENT OF
VIETNAMESE WORKERS WORKING FOR FOREIGN
ORGANIZATIONS, INDIVIDUALS IN VIET NAM

Pursuant to the Law on Government Organization dated June 19th, 2015; Law on amendment and supplement of several articles of the Law on Government Organization and the Law on Organization of Local Government dated November 22nd, 2019;

Pursuant to the Labour Code dated November 20th, 2019;

Pursuant to the Law on Investment dated June 17th, 2020;

Pursuant to the Enterprise Law dated June 17th, 2020;

At the proposal of the Minister of Labour, Invalids and Social Affairs;

The Government promulgates Decree for amendment and supplement of several articles of the Decree No. 152/2020/ND-CP dated December 30th, 2020 of the Government regarding foreign workers working in Vietnam and recruitment, management of Vietnamese workers working for organizations, foreign individuals in Vietnam.

- Article 1. Amendment and supplementment of several articles of the Decree No. 152/2020/ND-CP dated December 30th, 2020 of the Government regarding foreign workers working in Vietnam and recruitment, management of Vietnamese workers working for organizations, foreign individuals in Vietnam
- 1. Amendment and supplement of several points and clauses of Article 3 as follows:
 - a/ Amendment and supplement of Point a, Clause 3, Article 3 as follows:
- "a) University degree or higher or equivalent and at least 3 years of work experience suitable to the job position that the foreign worker expects to work in Vietnam.".
 - b/ Amendment and supplement of Clause 5, Article 3 as follows:
 - "5. Executive director is a person in one of the following cases:
 - a) The head of the branch, representative office or business location of the

enterprise.

- b) Those who lead and directly operate in at least one field of the agency, organization or enterprise and under the direct supervision and management of the head of the agency, organization or enterprise.".
 - c/ Amendment and supplement of Point a, Clause 6, Article 3 as follows:
- "a) Trained for at least 1 year and have at least 3 years of experience suitable to the job position that the foreign worker expects to work in Vietnam.".
 - 2. Amendment and supplement of Article 4 as follows:

"Article 4. Employing foreign workers

- 1. Determine the demand to employ foreign workers
- a) At least 15 days before the expected date of foreign workers employment, the employers (except the contractors) shall determine the demand for foreign workers for each job position that the Vietnamese workers have not been able to meet and report to the Ministry of Labour, Invalids and Social Affairs or the Department of Labour, Invalids and Social Affairs where the foreign worker expects to work according to Form No. 01/PLI Annex I issued under this Decree.

In the course of implementation, if the demand for using foreign workers changes in terms of position, job title, working form, number and location, the employers must report to the Ministry of Labour, Invalids and Social Affairs or the Department of Labour, Invalids and Social Affairs according to Form No. 02/PLI Annex I issued under this Decree within at least 15 days from the expected date of foreign workers employment.

- b) In the case of foreign workers prescribed in Clauses 3, 4, 5, 6 and 8, Article 154 of the Labour Code and Clauses 1, 2, 4, 5, 7, 8, 9, 10, 11, 12, 13 and 14, Article 7 of this Decree, the employer is not required to determine the demand to employ foreign workers.
- c) From January 1st, 2024, the recruitment announcement of Vietnamese workers to positions expected for foreign workers shall be made on the Electronic Information Portal of the Ministry of Labour, Invalids and Social Affairs (Department of Employment) or the Electronic Information Portal of the Employment Service Center established by the Chairman of the People's Committee at central level within at least 15 days from the expected date of reporting to the Ministry of Labour, Invalids and Social Affairs or the Department of Labour, Invalids and Social Affairs where the foreign worker expects to work. The content of the recruitment announcement includes: position and job title, job description, quantity, qualification requirements, experience, salary, working time and location. Should the employer failed to recruit Vietnamese workers to positions for foreign workers, then the employer shall determine the demand to employ foreign workers as prescribed at Point a, Clause 1 of this Article.

- 2. The Ministry of Labour, Invalids and Social Affairs or the Department of Labour, Invalids and Social Affairs shall approve or disapprove the employment of foreign workers for each job position according to Form No. 03/PLI Appendix I issued under this Decree within 10 working days from the date of receipt of the explanatory report; or report explaining changes in demand for foreign workers."
 - 3. Supplement of Clause 3 of Article 6 as follows:
- "3. In case foreign worker works for one employer in many provinces or central cities, then within 3 working days from the date the foreign worker starts working, the employer must submit e-report to the Ministry of Labour, Invalids and Social Affairs and the Department of Labour, Invalids and Social Affairs where the foreign workers work according to Form No. 17/PLI Annex I issued under this Decree."
 - 4. Amendment and supplement of several clauses of Article 7 as follows:
 - a/ Amendment and supplement of Clause 6 of Article 7 as follows:
- "6. Dispatched to Vietnam by a competent foreign agency or organization as teacher or manager or executive director of an educational institution which proposed to establish in Vietnam by a foreign diplomatic mission or intergovernmental organization; institutions and organizations established under international treaties to which Vietnam has signed and participated in."
 - b/ Amendment and supplement of Clause 14, Article 7 as follows:
- "14. To be certified by the Ministry of Education and Training for foreign workers to enter Vietnam to perform the following jobs:
 - a/ Teaching and research;
- b/ Managers, executive directors, principals and vice principals of educational institutions which proposed to be established in Vietnam by foreign diplomatic missions or intergovernmental organizations.".
- 5. Amendment and supplement of several points and clauses of Article 9 as follows:
 - a/ Amendment and supplement of Clause 1, Article 9 as follows:
- "1. A written application for a work permit by the employer according to Form No. 11/PLI Appendix I issued under this Decree. In case foreign worker works for one employer at more than one location, the written application for a work permit must fully list the work locations."
- b/ Amendment and supplement of Points a and b, Clause 4, Article 9 as follows:
- "a) Manager or executive director proving documents as prescribed in Clauses 4 and 5, Article 3 of this Decree, include the following 3 types of documents:

Company charter or operating regulations of agencies, organizations or enterprises;

Business registration certificate or establishment certificate or establishment decision or other documents of equivalent legal value;

Resolution or Appointment Decision of agencies, organizations or enterprises.

b) Experts and technical Labour proving documents as prescribed in Clauses 3 and 6, Article 3 of this Decree, include the following 02 types of documents:

Diploma or certificate or authenticated document;

Written confirmation from agencies, organizations, or enterprises in foreign countries regarding years of experience of the expert, technical worker, or issued work permit or issued Confirmation of not subject to a work permit".

- c/ Amendment and supplement the name of Clause 8, Article 9 as follows:
- "8. Documents related to foreign workers, except for the case of foreign workers prescribed at Point a, Clause 1, Article 2 of this Decree.".
 - d/ Amendment and supplement of Point e, Clause 8, Article 9 as follows:
- "e) For foreign workers working as prescribed at Point i, Clause 1, Article 2 of this Decree, there must be a document from the foreign agency, organization or enterprise dispatching the foreign workers to work in Vietnam and suitable to the expected job position, or managers proving documents as prescribed in Clause 4 Article 3 of this Decree."
 - dd) Supplement of Point c, Clause 9, Article 9 as follows:
- "c) For foreign workers who are experts and technical workers who have been granted a work permit and have had it extended once but desire to continue working in the same job position and title written in the work permit, then the application dossier for a new work permit includes the documents prescribed in Clauses 1, 2, 5, 6, 7, 8 of this Article and a copy of the issued work permit ".
 - 6. Amendment and supplement of Clause 2 of Article 11 as follows:
- "2. Within 05 working days after receiving a complete application for a work permit, the Ministry of Labour, Invalids and Social Affairs or the Department of Labour, Invalids and Social Affairs where the foreign worker expects to work shall issue a work permit to the foreign worker according to Form No. 12/PLI Appendix I issued under this Decree. In case of refusal then a written reply clearly state the reason shall be given.

The work permit is A4 size (21 cm x 29.7 cm), consist of 02 pages: page 1 is blue; page 2 has a white background, blue pattern with star shape in the middle. Work permits are coded as follows: codes of provinces and central cities and codes of the Ministry of Labour, Invalids and Social Affairs according to Form No. 16/PLI Appendix I issued under this Decree; the last 2 digits is the year

of issuance; type of license (new issuance is marked as 1; renewal is marked as 2; re- issuance is marked as 3); sequence number (from 000.001).

In case the work permit is in electronic copy, then it must comply with relevant laws and meet the required contents according to Form No. 12/PLI Annex I issued under this Decree."

- 7. Amendment and supplement of Clause 3 of Article 12 as follows:
- "3. Change one of the following contents: full name, nationality, passport number, work location, change of business name without changing the registration number stated in the valid work permit."
 - 8. Amendment and supplement of Clause 7 of Article 17 as follows:

"One of the documents prescribed in Clause 8, Article 9 of this Decree proves that the foreign worker continues to work for the employer according to the content of the issued work permit, unless the foreign worker works as prescribed at Point a, Clause 1, Article 2 of this Decree."

- 9. Amendment and supplement of Point b, Clause 1, Article 22 as follows:
- "b) Organizations that are decentralized, delegated, assigned, ordered or tendered by People's Committees at provincial-level.".
 - 10. Amendment and supplement of Point b, Clause 4, Article 27 as follows:
- "b) Organizations that are decentralized, authorized, assigned, ordered or tendered by People's Committees at provincial-level to recruit and manage Vietnamese workers working for foreign organizations and individuals shall report to the Department of Labour, Invalids and Social Affairs."
- 11. Amendment and supplement of several points and clauses of Article 30 as follows:
 - a/ Amendment and supplement of Point a, Clause 1, Article 30 as follows:
- "a) Approve the demand to employ foreign workers; certify cases of not being subject to a work permit; issue, re-issue, extend and revoke work permits of foreign workers in one of the following cases:

Working for the employers prescribed in Point g, Clause 2, Article 2 and the employers prescribed in Points *c*, d, e, Clause 2, Article 2 of this Decree whose establishment are authorized by the Government, the Prime Minister, ministries and branches:

Work for one employer in many provinces and central cities.".

- b/ Amendment and supplement of Point c, Clause 1, Article 30 as follows:
- "c) Perform the unified state management on recruitment and management of foreign workers working in Vietnam from central to local levels and manage Vietnamese workers for foreign organizations and individuals in Vietnam."

- c/ Amendment and supplement of Clause 3, Article 30 as follows:
- "3. Mandates of the Ministry of Defence:
- a/ Coordinate with competent agencies in charge of foreign workers and Vietnamese workers working for foreign organizations and individuals in Vietnam in pursuant to the provisions of law regarding ensuring security and order in strategic, key and weak areas for national defense.
- b/ Direct the Border Guards to coordinate with functional forces in management and inspection of Vietnamese workers working for foreign organizations and individuals in Vietnam and foreign workers working in border areas, border gates, islands and maritime areas in order to firmly protect territorial sovereignty, security, national borders of the Fatherland."
 - d/ Amendment and supplement of Point a, Clause 4, Article 30 as follows:
- "a) Monthly provide the Ministry of Labour, Invalids and Social Affairs with information on foreign workers granted visas with symbols including: DN1, DN2, LV1, LV2, LĐ1, LĐ2, DT1, DT2, DT3, DT4 to work for agencies, organizations and enterprises;".
- dd) Amendment and supplement of Point a, Clause 6, Article 30 as follows:
- "a) Approve the demand to employ foreign workers; certify cases of not being subject to a work permit; issue, re-issue, extend and revoke work permits of foreign workers in one of the following cases:

Working for the employers prescribed at Points a, b, h, i, k, l, Clause 2, Article 2 and the agencies and organizations prescribed at Points c, d, e, Clause 2, Article 2 of this Decree whose established by People's Committees at provincial-level, specialized agencies under People's Committees at provincial-level, People's Committees at district-level;

Working for employers at multiple locations in the same province or central city.".

- 12. Amendment and supplement of several templates as follows:
- a) Amendment of Form No. 01/PLI; Form No. 02/PLI; Form No. 07/PLI; Form No. 08/PLI Annex I issued under Decree No. 152/2020/ND-CP into Form No. 01/PLI; Form No. 02/PLI; Form No. 07/PLI; Form No. 08/PLI Appendix issued under this Decree;
- b) Supplement of Form No. 16/PLI and Form No. 17/PL1 to Appendix I issued under Decree No. 152/2020/ND-CP.

- c) Replace the phrase "translated into Vietnamese and certified" with "translated into Vietnamese and notarized or authenticated" at Point e, Clause 3, Article 8;
- d) Replace the phrase "translated into Vietnamese and authenticated" with "translated into Vietnamese and notarized or authenticated" in Clause 10, Article 9 and Clause 4, Article 23;
- dd) Replace the phrase "Documents prescribed in Clauses 3 and 4 of this Article" with "Documents prescribed in Clause 3 of this Article" in Clause 5, Article 13:
- e) Replace the phrase "translated into Vietnamese" with "translated into Vietnamese and notarized or authenticated" in Clause 5, Article 13 and Clause 8, Article 17;
- g) Replace the phrase "Certified copy of passport" with "Certified copy of passport or copy of passport certified by the employer" at Point d, Clause 3, Article 8; Clause 7 of Article 9 and Clause 5 of Article 17;
- h) Replace the phrase "20. Salary:....VND" with "20. Average salary / month: million VND" in Form No. 11/PLI Appendix I issued under Decree No. 152/2020/ND-CP;
- i) Replace the phrase "People's Committee of the province/city" with "Department of Labour, Invalids and Social Affairs." in Form No. 03/PLI Appendix I issued under Decree No. 152/2020/ND-CP;
- k) Replace the phrase "Director General/Chairman of the People's Committee at provincial-level" with the phrase "Director General/Director"; replace the phrase "At the request per document No." with "At the request and the contents, information provided in document No." in Form No. 03/PLI Appendix I issued under Decree No. 152/2020/ND-CP;
- l) Replace the phrase "Chairman of the People's Committee of the province/city..." with "Department of Labour, Invalids and Social Affairs. " in Form No. 04/PLI, Form No. 05/PLI, Form No. 06/PLI Annex I issued under Decree No. 152/2020/ND-CP;

Article 2. Abolition of several provisions of the Decree No. 35/2022/ND-CP dated May 28th, 2022 of the Government regarding management of industrial parks and economic zones

- 1. Abolish the opening paragraph "Issuance, re-issuance, extension and revocation of work permits, and certification of foreign workers not subject to work permits for foreigners working in industrial parks or economic zones" and the phrase "receipt of foreign workers' employment report" at Point dd, Clause 2, Article 68.
- 2. To abolish the paragraph "receipt of reports from enterprises in industrial parks or economic zones regarding the demand to employ foreigners for each job position that Vietnamese workers have not been able to meet " at Point c, Clause 3, Article 68.

Article 3. Enforcement Terms

- 1. This Decree takes effect from September 18th, 2023.
- 2. Transitional Terms:

For the report explaining the demand to employ foreign workers, the confirmation request dossier for not subject to work permit; Issuance, reissuance, extension of work permits submitted by foreign employers to the Ministry of Labour, Invalids and Social Affairs, People's Committees at provincial-level, Departments of Labour, Invalids and Social Affairs, Management Boards of industrial parks, economic zones and hi-tech parks, before the effective date of this Decree, shall apply in pursuant to Decree No. 152/2020/ND-CP dated December 30th, 2020 of the Government regarding foreign workers working in Vietnam, and recruitment, management of Vietnamese workers working for foreign organizations and individuals in

Vietnam, and Decree No. 35/2022/ND-CP dated May 28th, 2022 of the Government regarding management of industrial parks and economic zones.
